With current funds we can complete system commissioning and additional construction activities on the core of our system and have ~\$1.2M remaining to apply to construction of the site with the next highest priority.

Site Prioritization - Site Removal



- 1. Smokey Quartz
 - a) Primary coverage areas: City of Sparks, Spanish Springs, Golden Eagle Park
- 2. Seven Lakes
 - a) Primary coverage areas: Red Rock, Rancho Haven, Fish Springs
- 3. Ash Field
 - a) Primary coverage areas: Vya, northern Washoe County where there is currently no radio coverage.
- Removing a site from the NSRS requires review by all three NSRS member agencies. Through a "Request for change" process, NSRS members would determine technical and operational impacts of site removal.
- Formal site removal requires each agency to execute a Change Order to their respective contract with L3Harris, accepting the change in radio coverage for the statewide system.

Washoe County NSRS Milestone Payments



- 1. System Purchase Agreement Signing: \$533,981.25 (September 2018)
- Commence Network Switching Center (NSC) Install: \$796,005.24 (November 2019)
- 3. NSC Install Complete: \$1,194,007.86 (January 2020)
- 4. Approval of Detailed Design Review: \$918,728.31 (November 2021)
- 5. Region 2 Factory Staging: \$1,194,007.86 (February 2022)
- Region 2 shipment of Radio System Equipment: \$1,592,010.48 (February 2022)
- 7. Region 2 Radio System Installation complete & accepted: \$1,194,007.86
- 8. Final System Acceptance: \$537,303.54

Washoe County NSRS Change Orders



- Modify Milestone Payments Schedule No Cost
- 2. Initiate Site Surveys
 - a) Notice to proceed on site surveys \$322,048
- 3. Site Remediation, notice to proceed \$45,304.43
- 4. Console feature update and invoicing \$18,204
- Extend Console pricing to all console purchases through Harris Contract No Cost
- 6. Console Router model change No cost
- 7. Greenfield site civil construction
 - a) Notice to proceed \$3,819,300.02 for greenfield site construction
 - b) Cost is within contract pricing
- 8. Microwave System
 - a) Notice to proceed with \$2,331,727.35 for new microwave system installation
 - b) \$95,081 greater than contract pricing for Microwave System

Washoe County NSRS Change Orders (cont'd)



- 9. Smart Breaker Design Notice to proceed \$6,910
- 10. Fox Mtn. Solar Notice to Proceed \$385,660.70 (Funded through WCRCS Infrastructure)
- 11. Remove 49 Mtn from contract Notice to proceed on additional \$220,908.82 for civil construction.
- 12. Reconcile civil construction cost changes No cost, but resulted in payment of \$2,256,246.53
- 13. SOW language change under "Software FX with SUMS and Tait Software Maintenance Installation" No Cost
- 14. Region 1 and Region 2 Delayed Sites, Milestone Pro-rate No Cost
- 15. Renumber Milestone numbers; Allow Quinn Korbulic to execute documents while Melissa Lawney is on medical leave No Cost

Considering all Change Orders, the total Contract Amount has increased by \$49,305.60 to \$26,586,816.28
